THE PROBLEM

STOP THE TRAFFIK Group* (STTG) works with businesses and organisations to eradicate modern slavery and human trafficking (MSHT) across their operations. It is estimated that the scale of MSHT exceeds \$150 Billion in revenue per year with over 50 million individuals trafficked annually. At this rate, the potential profit for a trafficker is upwards of \$200,000 per victim while the cost of risk is under \$100 (The Avery Centre, 2021).

WHY STTG?

MSHT devastates individual lives, families, and makes our communities unsafe. Human trafficking is the biggest criminal industry in the world, but together we can be a part of the solution.

We have a proven model to prevent MSHT, raising the risk to traffickers, creating an environment where their business model will fail to exist.
